CAPTAINS REPORT November 2001

I will start by saying that although I was unable to attend the recent English County Championships at Hemsby, I was very disappointed with the end result. Particularly after the efforts of the team during the first day's play. Our final position was the lowest we have ever had. It appears that once again we were either unable to hold our form together, or that we do not have the right sort of fighting spirit to carry us through when things go wrong (which they will inevitably do).

These thoughts were also in my mind during the League match yesterday when we were playing Norfolk at Banham.

The match was played using the familiar format of five sessions on four carpets. The first session was a very close thing with both Counties winning two games each. In the two games Suffolk lost, there was only one shot difference in each game. 14 – 2, 10 – 9, 10 – 11, 5 – 6.

Session two went to Suffolk by three games to one, again the Suffolk loss was by one shot. 11 – 5, 11 – 6, 14 – 3, 9 – 10.

In the third session there are just two games and one went to each County. 11 – 2, 4 – 9

Suffolk were now leading 12 points to 8.

The fourth session was again halved with two games each.

15 – 5, 9 – 5, 6 – 12, 3 – 10.

In the final session Suffolk needed to win two games to secure the victory, unfortunately this was beyond us and we had to be content with a draw 9 – 4, 5 – 8, 5 – 9, 5 – 8..

A disappointing end to a day that started out so promisingly.

For this match some new players were brought in and will obviously need some time to bed themselves in, as will other players the other selectors myself and have our eyes on. We have to rekindle the team spirit and fight that brought us the number one spot in Carpet Bowls a few years ago.
