**The Minutes of a Committee Meeting of the  
Suffolk Carpet Bowls Association  
held at Needham Market Community Centre  
on Monday 22nd September, 2003**

**The Meeting commenced at 7.30 p.m.**

**Those present:-** David Schofield (Chairman), Margaret Southgate (Vice Chairman), Marion Brown (Secretary) Paul Goulding (Treasurer), Derek Brown, David Cask, Rita Daniels, Jim Goodrich, Sally Goodrich, Richard Sago, and Tony Webber.

1. **Apologies.** from Keith Armes and John Varden were received.
2. **The Minutes of the previous meeting** were approved and signed.
3. **Matters Arising:-** There were no matters arising.
4. **Co-option.**  
The Chairman asked that Arvon Evans be co-opted onto the Committee. Arvon had been a member for several years and had expressed a wish to stand down at the 2003 Annual General Meeting but David said that he had asked him to reconsider and this he had done. The Committee agreed this co-option. The Committee would like to remind Clubs and Members in the County that there are still vacancies on the Committee and that they would be very grateful for offers to fill these positions. Your offers of assistance by becoming a member of the Committee would help share the work load of those already on there. Offers please to the Secretary or Chairman.
5. **Chairman's report:-**
  - a) The Chairman reminded the meeting that at the previous meeting members were asked to be concise and to the point with matters they wish to comment on but continued by pointing out that even so the meeting still ran for over 3 hours.  
The Chairman continued his report with the suggestion that Sally Goodrich should hold the position of Match Secretary on this Committee and not Press Secretary and that another person should become Press Secretary and this person would be responsible for writing reports within the County. Sally as Match Secretary would continue to send league results to the press. The members of the committee were asked to give this their consideration as to who might fill this position.
  - b) **Bowls Council**  
The Chairman reported that he had written to the ECBA to ask them to take immediate steps to be included with other forms of bowls in a body to be recognised by Sport England. The ECBA Secretary had responded to this letter confirming that she had taken such steps.
  - c) **Open Day**  
The Chairman proposed the period 15th to 20th March 2004 becomes a 'Publicity Week' for Carpet Bowls in Suffolk. More details after the November meeting.
6. **Secretary's report:-**
  - a) Marion reported that a visit to assist Westhorp with setting up carpet bowls had taken place. She reported that they only had facilities for one carpet. It was pointed out with only one carpet they would be unable to take part in the Suffolk Leagues but they would be eligible to play in the Closed Championships etc.
  - b) A letter had been received from Andy Gilder who organised the Suffolk Junior/Senior tournament held on 31st August. He reported that all had enjoyed the day and a high standard of bowling was achieved. Andy felt he was unhappy about a couple of things on the day such as over running by quite a bit of time, also he felt that he should have played to the whistle. These comments were discussed and noted, the Committee said that those there thoroughly enjoyed the day. The winners

were Oscar Mew & Mike Daniel's from Kelsale C.B.C. the runners up also from Kelsale were Joe Mew & Paul Daniels, the semi finalists were Paul Davidson and Pat Noble from Gt. Barton C.B.C. with Laura Battle from Sizewell C.B.C. playing with Rita Daniels from Kelsale.

Andy said that if the Committee wished he would organise the event in 2004, the Committee agreed to this and asked Marion to write to him and thank him and say that we would like him to do this.

Date confirmed as 29th August 2004 at Needham Market Community Centre.

- c) A letter had been received from The Federation of Eastern Sport regarding a seminar to be held at Cambridge University Athletics Club on Wednesday 19th November 2002. The seminar is particularly relevant to those clubs that have their own premises and raise funds through trading activities and will therefore benefit from the legislation and reduce the taxation burden. The Committee will get some brochures regarding this and anyone interested please contact Marion.
- d) Suffolk Closed Junior Tournament. The date for this is February 29th 2004 and this will again be organised by John Hayward. Entry forms will be included with the November minutes.

**7. Match Officer's Report.**

- a) Sally reported that she had now received all the Suffolk Leagues fixtures dates but at the time of this meeting 8 teams in the West and 12 teams in the East had not yet commenced their fixtures. The first round of the Joe Rice Cup had started.
- b) The Summer league finals day had been held the day previous to this meeting and Belstead had become the Summer League Champions. However, an observation had been made by several interested parties that some Clubs were playing members of their Club who had not competed in the team during the season. This was discussed by the Committee and to be included in next seasons Summer League Rules would be a clause stating that to be eligible to play in the finals a player would have had to have played in at least three (3) games during the season.
- c) League Results:- Sally would like to remind Clubs that results are only sent to clubs who request them by sending her a stamped addressed envelope for this purpose, Sally would also like to remind members that because results arrive with her nearly every day it is not possible to have a true picture of these at all times.

- e) Rita Daniels asked if the County had Public Liability insurance as this was mandatory when hiring Leiston Leisure Centre for the Closed Championships. This was confirmed. At the same time Rita also asked that if a carpet belonging to a Club became damaged whilst being used at a Closed Championship event and a claim was made on the Clubs insurance would the S.C.B.A. reimburse the Club for the excess of £50.00 which would have to be paid on a claim. The Committee agreed that the S.C.B.A. would do this.

**10. Eastern Counties Carpet Bowls Association Report**

There was no report as there had been no meeting and Margaret Southgate reported that the next meeting would take place on 16th October. Tony Webber said that he would be unable to attend as our delegate. Margaret Southgate offered to act as delegate.

**11. English Carpet Bowls Association Report**

- a) The E.C.B.A. Rinks Tournament 2004 will be held on 28th March 2004 at Hadleigh High Leisure Centre. Entry forms for this will be sent in due course. Suffolk will host this event.

- b) **Courses for Referees:-** Richard Sago reported that one course had already taken place and that if there was enough interest another would take place. Several members of the Committee booked places for the next training session.

12. **Any other business.**

## SUFFOLK CARPET BOWLS ASSOCIATION SUMMER LEAGUE PLAY – OFF

The 2003 Summer League group winners came together on Sunday 21<sup>st</sup> September, to decide which of the six clubs would be the Champion for this year.

The Play – offs took place at the Needham Market Community Centre and were played on six mats with each of the six clubs playing the other five in either the Fours or the Pairs. Each club played with 2 Fours and 2 Pairs plus a nominated Pair in the third session. All games were played over 11 ends.

The first session was for the Fours and meant that Barking had to face Gt. Blakenham and Brockley. Belstead had to face Tithe Barn and Chelmondiston. Brockley also had to play Chelmondiston with Gt. Blakenham playing Tithe Barn on the sixth mat.

After this session Belstead and Brockley had 4 points each, having won both of their games. Gt. Blakenham and Tithe Barn had 2 points, to leave Chelmondiston and Barking trailing with no points.

Session two was for the Pairs and brought together Chelmondiston versus Barking and Gt. Blakenham, Tithe Barn versus Brockley and Barking and Belstead versus Gt. Blakenham and Brockley.

In this session Belstead again scored 4 points, Barking also gained 4 points by winning their two games. Both Gt. Blakenham and Tithe Barn managed one win to get 2 points each. This left Chelmondiston trailing without a point. This meant that Belstead could not be caught and that Chelmondiston would be playing for their pride in the final session.

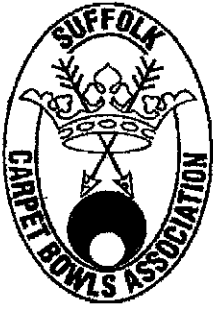
The third session was for the Nominated Pairs and brought together Belstead against Barking, Tithe Barn against Chelmondiston and Brockley against Gt. Blakenham.

This time Chelmondiston came good at the expense of Tithe Barn to win their first 2 points. Belstead dropped their first 2 points when they were beaten by Barking. In the last game Brockley took the 2 points from Gt. Blakenham.

There was a lot off good bowling during the day, but some of the players struggled to master the pace and swing of the mats. This plus the tension of the day made for a really good competition. As is usual for Carpet Bowls all the games were played in a friendly but competitive way, which makes our sport such a pleasure to be part of.

## SUFFOLK versus DURHAM THE ANNUAL ENCOUNTER

This year it was the turn of Suffolk to do the entertaining in our annual friendly clash with Durham. The Needham Market Community Centre was the venue for this weekend of bowling and is where most of the County games take place. On Sunday the Suffolk team were keen to get back the shield that was lost at Chester le Street in 2002. However, before that could happen, the pairs competition, a forerunner to the main match had to be played on Saturday afternoon.

In this competition a Suffolk player is paired up with a Durham player and the 32 pairs are then divided into groups of four, to play in a round robin tournament. The competition began at 1 – 30 pm and continued until about 6 – 30 pm when the winners finally emerged.

The standard of bowls was very high, as you would expect from pairs consisting mainly of County level bowlers. Those bowlers who were not part of the County squads, all managed to raise their games to add to the good play that was on show throughout the day.

The 8 group winners who went through to the knockout rounds were, Joyce Woodward & Michael Ashman, Penny Harvey & Mary Guy, Shirley Woods & Roy Lonsborough, Marion Brown & John Varden, Danny Morgan & Paul Daniels, Mike Daniels & James Stewart, Kay Masters & Keith Shepherd, Peter Jones & Neil Ridley

After some hard fought and very tight games the eventual winners were Shirley Wood (Durham) & Roy Lonsborough (Suffolk), who beat Peter Jones (Suffolk) & Neil Ridley (Durham) in the final.

Once the bowls presentation was over, it was time to sit down to a superb meal provided by Rita Daniels and her staff. As well as organising the meal Rita was also bowling in the competition (a glutton for punishment you could say). After the meal and a few drinks everyone went off to either their hotel or their homes to prepare for another effort on the Sunday.

The County match on Sunday was played with the usual 24 players in each team playing in rinks of 4. The competition was played on 4 mats over 6 sessions, with each rink playing 4 games.

Play commenced at 9 – 30 and the first session was all Suffolk as they took all 4 games and by 53 shots to 15.

The second session was a much closer affair with each team winning 2 games, shots were also close at 24 to 26 in favour of Durham.

Session 3 brought Suffolk through again by 3 games to 1 and with 35 shots to 19.

The fourth session was again even at 2 games each, with once more Durham shading the shots by 34 to 31.

Session five was a good one for Durham as they won 2 games and shared 1, Durham also had a good shots score at 32 to 24.

The final session belonged to Suffolk although the shots were very close, Suffolk won 3 games and Durham 1. Shots were 33 to 30 in favour of Suffolk.

The result was a win for Suffolk by 31 Points to 17, shots were 200 to 156 also in favour of Suffolk.

It was a hard fought match, but Durham were unable to recover from the bad first session and were always having to play a catch up game.

Regardless of the bowls result, the real winner was bowls itself and the friendship between our two counties. Long may it remain this way.



#### ECBA Committee Meeting 5th July 2003

7 Counties attended, with apologies from Norfolk and South Tyneside, I also gave apologies from Richard Sago and said that I was acting as Suffolk Delegate. The minutes of the last meeting were signed with no matters arising. The secretary had received a request from Orkney for information on the rules of the game and from Stockton on Tees for help in setting up an Association, they want help in formulating a constitution. The Chairmans report gave thanks to all who contributed to the success of the Champion of Champions at Barnsley, David Storey as Referee, North Tyneside for running the Raffle and Ann Hardy and Margaret Southgate for the administration over the weekend. He also told the meeting that the Northern League had met with representatives of Sunderland City and it has been agreed that they will be invited to join the league this year, so it would appear that within this coming year Sunderland will again apply to join the ECBA.. The secretary had a very short report, the main item being a request for a copy of each counties diary of events so that a calender of the main competitions can be published. The treasurer reported a total of £11,398.93 in the bank at the moment but pointed out that the account for the Metrodome had not yet been received and the admin expenses had not been paid. The referee said that courses were being held for the training of more referees and by November we should have sufficient for the championships. At present we have 19 people qualified. Hertfordshire have received 70 entries for the Triples in September, which is being held at Ware. Booking forms are now available for November and were distributed to all counties present. Durham raised the question of the travel subsidy, suggesting an increase of 33%, after much discussion it was decided that instead of the counties not claiming for the first 200 miles of the total distance travelled this would be reduced to 100 miles. This will mean an increase of £100.00 per county who are currently entitled to a subsidy plus a further 4 counties in this region will be entitled to claim a subsidy. (In our case I understand it will be £10.00) The chairman then raised the matter of our trophies, he had brought to the meeting the shield he had won at Barnsley and said it was not in very good condition, it was scratched and chipped. Why is it that people do not look after trophies when they win them? It was decided that all the shields would be returned to the committee at the meeting in April next year and Jim Southgate will refurbish them for us.

Reviewing the AGM the treasurer suggested that the rule books should be reprinted with the changes voted for at the Agm and sufficient copies should be given to the counties for each of their member clubs. This was agreed and all counties asked to give the treasurer the number of books required. All qualified referees will also receive a new rule book. The new rules will be operative for the winter season, also at the ECBA Triples in September. The chairman would like all county committees to look at the constitution to see if there is anything in there which they consider should be altered or added to, and bring any comments to the next meeting.

Under AOB Hertfordshire asked if the date of the Champion of Champions could be changed around with the Eastern Counties date as this had been discussed at the Eastern Counties AGM but after a vote was taken the result was 3 in favour and 3 against with 1 abstaining, this meant the chairman had the casting vote and he voted against it.
